Thank you for time on the phone this evening. It is good to be in touch.

I am attaching the initial leaflet that gives a good basic explanation of the scheme. Also the current "Frequently asked questions" document.

If someone just wants to commit their voucher now, please tell them to go to <https://www.openreach.com/connectmycommunity> It literally only takes 5 minutes!

This is actually a joint project, which covers two telephone exchanges:

- the Brightling telephone exchange (Brightling + Netherfield Village + Dallington Woods Corner area)
- the Ashburnham telephone exchange (Ashburnham, Penhurst and Ninfield).

... and Andrew Hoad, chairman of Ashburnham and Penhurst Parish council, is leading the project. That is why the leaflet refers to the Ashburnham and Penhurst web site.

The postcodes in Brightling, Netherfield and Woods Corner are at the end of this message. If a postcode doesn't appear in this list, it is either because it is outside the scheme area, or because the whole postcode has already got full fibre broadband. The leaflet will only be going to properties in the list - so if people aren't eligible they won't get sent a leaflet.

It is important to note that individuals are not being asked to contribute to the cost of the upgrade. They are simply being asked to pledge their Rural Gigabit vouchers (of £1500 or £3500) and commit to taking up a new service within 12 months of the completion of the new fibre network (if it goes ahead). This is not a big commitment because the new service will in many cases cost little more - or even less - than people's existing service.
